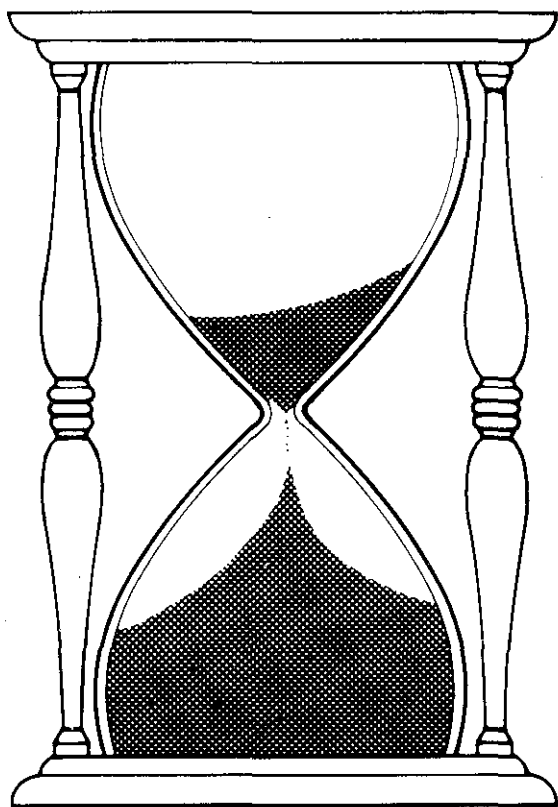

PREFACE

This is the fourth H.G.R.G. Register of Research in historical geography. The third Register was produced in 1980 by Trevor Wild and listed 543 topics covering a wide range of subjects, areas and periods. Since 1980 a considerable number of new people have begun research in historical geography and many of the existing workers have moved on to new topics.

As in previous publications the Fourth Register does not limit its scope to the work of Group members. The response from many parts of the world to requests for information has been very encouraging both from private individuals and members of university and college departments in many disciplines. The editor is grateful to all those who have provided details of their work. The Register could not have been produced without these contributions.

The Register cannot claim to be an exhaustive catalogue of research in historical geography, but it does include references to a considerable amount of the work which is being undertaken in the U.K. together with some of the research which is being carried out overseas. The Register lists 495 topics, all of which have been included in replies to the questionnaire. The practice of including 'non-respondents' and their last known research topic, which was used for the 1980 Register, has not been adopted.

The editor is grateful to Ian Whyte for his help and advice during the preparation of the Register and particularly for his work of typing the draft of the text.
