

PREFACE

The first HGRG Register of Research was produced nine years ago as a list of members' research interests. In 1976 Harold Fox edited a second register which provided a more complete coverage of current research work in historical geography and an impressive list of 529 topics.

As in the 1976 publication, the third Register of Research does not limit its entrants to group members. Its degree of completeness reflects the diligence of fellow researchers in responding to requests for information circulated at various times during 1979. Happily we are able to welcome a healthy number of new entrants and their topics; but many workers listed in the previous Register have not responded. Undoubtedly some have left the field of historical geography, but there are others whom the HGRG Committee felt should not be left out from the new Register. Accordingly I have taken the liberty of including some 'non-respondents' and their 1976 topics, with the hope that this meets with the understanding and blessing of those concerned. As a precaution their names are accompanied with an asterisk, and readers are advised that in these cases it is quite possible that some of the associated research topics have already been completed.

Like its two forerunners, the third Register of Research can not claim to be an exhaustive catalogue of research in our subject; but its total of 543 topic entries does include a broad coverage of the work currently being undertaken within the United Kingdom, both in private and in our various educational and research institutions. Also we must be very grateful for the welcome response from colleagues in other countries, mainly from the United States, Canada, Australia, and the Republic of Ireland, but also from continental Europe and elsewhere.

For the sake of presentation and space, details of postal address are not provided for entrants based in British universities and polytechnics. For the same reasons, it was decided not to include departmental affiliations: this information is readily available in up-to-date issues of the International Handbook of Universities, the Commonwealth Universities Yearbook, the Handbook of Polytechnic Courses, and the Handbook of Colleges and Departments of Education.

Entries have been indexed in the subject, locational and chronological keys which are to be found on pages 31 to 36. The arrangement of the subject key is somewhat different from that of the previous Register, with alterations mainly being improvised to allow for a noticeable upsurge in research interest within the field of urban historical geography. The locational key has also been modified to cater for a tendency towards more specific study areas, especially in Europe. The chronological key is unaltered, though it can be seen that more than half the code numbers are set within the nineteenth century.

My thanks go to fellow members of the HGRG Committee (1977-80) who have given considerable help and advice at all stages of preparation of this Register. The editor also wishes to take the opportunity of thanking the Social Science Research Council for its generous financial assistance towards the costs of publication.
