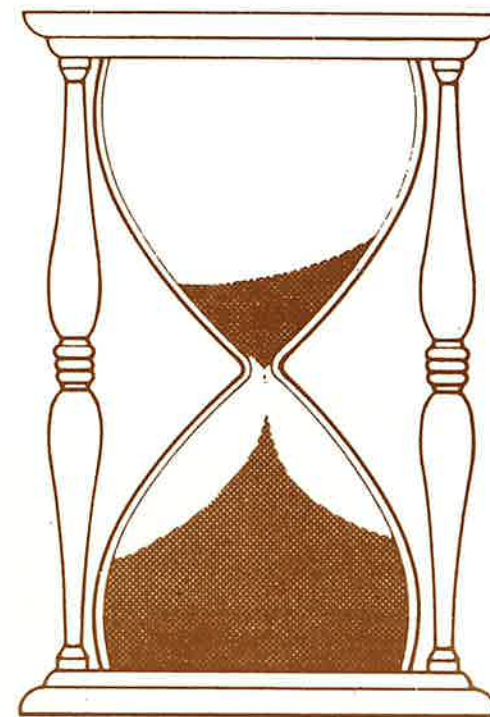

PREFACE

It is now almost four years since the fourth H.G.R.G. Register of Research in Historical Geography was produced. Unfortunately this, the fifth Register of Research, contains still fewer entries than did the fourth or third registers. This may be a reflection of the reduction of resources available for higher education in general, and particularly in a reduction in the number of new historical geographers entering the system, or it may indicate that some people who have active research interests have been unable to spare the time to complete the questionnaire. This is a pity, at a time when disciplines are anxious to be seen to be active as well as merely being so.

It is encouraging nevertheless that a number of new people have begun research in historical geography and that established researchers have ventured into new topics since the last register was produced. It is also pleasing that once again the register covers work which is being carried out in widely distributed parts of the world and in a number of disciplines. It is often fruitless to consider where the boundaries of a subject lie and it may be that some individuals would not consider all topics listed in the Register as historical geography. Each of them is considered to be such by the person who submitted it, and it was felt that no useful purpose would be served by too rigid a definition of the subject.

No register of research can be considered to be exhaustive and this one is certainly not so, but it does cover a substantial amount of the work which is being undertaken in the U.K. and some of that from overseas. It is hoped that it will be a useful starting point for those wishing to embark on research or merely to know what is being done in a particular area.

The editor is grateful to all those who have provided material for inclusion in the Register; the success of a publication of this type depends on such contributors. Thanks are also due to Ian Whyte for his help and advice during the preparation of the register and to Charles Withers for editing and preparing earlier drafts and arranging for the manuscript to be typed.
